Slovenske Piesky wants to be very friendly, relaxed and informal event, with the minimum of rules and restrictions. However, your co-operation with our simple safety and legal requirements is greatly appreciated. We would be grateful if you abide by the guidelines we have set down.

### **All Military Vehicle Entrants**

Upon entry to the show please ensure your vehicle sticker with your entry number is appropriately attached to your vehicle on arrival. This is also necessary for your vehicle to be judged.

### **Person Passes for Exhibitors**

## **Show Safety**

These will be issued on arrival to each individual. Please ensure these are worn by yourself and your guest or assistant at all times. Extra passes will be available upon entry to the show site.

### **Arrival for Exhibitors**

Arriving may start as of Monday 6th August, 2012, departure must be by Monday 13th August, 2012 unless previously arranged.

### **Fuel / Gas**

The nearest fuel station is in 12 km, open 24 hours.

### **Exhibitors / static and dynamic displays**

On arrival please report to the reception where you will be provided with your welcome pack. At this time you may settle any outstanding bills with the stewards prior to you moving onto the site to your allocated area.

### **Záhorie area**

Záhorie area is borrowed military landed property. Please remember that whilst on the site you are a guest and you are supposed to treat the site with the same respect you would treat your own property.

### **Camps and Campers**

There is a camping area near the arena where period camps can be set. Please specify required size and period reference in the application form. You will be allotted with appropriate area. The best camp will be priced. Civil vehicles are not allowed to park in the camp. Possible civil belongings must be covered not to disturb military character of the camp. Military vehicles are allowed to park in the camp. To enable visitors admiring your vehicles they should be labelled with a sign of type and history.

### **20 km/h – Speed Limit**

It is applied within the whole showground. No unauthorised moving of vehicles during events. Drivers are to obey instructions from officials and their assistants.

### **Tracked Vehicle Movement**

All movement through the site must be with at least one escort person on foot in front of the vehicle wearing high visibility attire. The 15 km/h speed limits apply unless you are in the arena where 40 km/h applies. Do not enter the safety zone (area of 15 m in front of the audience). All passengers to be seated on appropriate seats, not on vehicle turrets during displays. You could be prosecuted for driving recklessly at this type of event if it was considered that you have endangered the lives of other exhibitors or members of the public.

### **Vehicle Movement**

We ask that vehicle movement is kept to a minimum. In such a way dustiness and noisiness will be reduced and safety will be improved. No other vehicles (e.g. are allowed in the stallholder area on show days (Saturday) between the hours of 9.00am and 6.00pm. Only persons licensed to drive may operate vehicles. Children may not ride motorcycles or quads during the show days. All vehicles must abide by this. Emergencies excepted unless pre-arranged with the agreement of the Organisers. Due to less discipline of quad drivers in the past, are quads forbidden.

### **4 x 4 Course**

The entry will be marshalled by the Organisers. During racing hours according to the schedule only vehicles registered to particular race will be allowed to enter the course. Except for these hours vehicles for free riding are allowed to enter the course. In such a case there will be a small charges to cover costs. All participants wishing to take their vehicles on the 4 x 4 course can do it only at their own risk. The decision of the organisers will be final. Opening times are 9.00 am to 6.00 pm, Thursday to Sunday.

### **One-Way System in Operation**

One-way system will be in operation and all vehicles must abide by this. Vehicles are not permitted to leave the site between 9.00am and 6.00 pm on Saturday. Emergencies excepted unless pre-arranged with the agreement of the Organisers. Any vehicle not displaying a pass will be stopped by Officials.

### **Weapons**

Only vehicle mounted weapons or those as part of a static display will be allowed on the site. These must remain secure at all times and must comply with current statutory regulations. No function weapons are to be carried around on the site. No blank rounds or pyrotechnics may be brought on the site unless pre-arranged with the Organisers. The Organisers must insist that all weapons brought onto the site for display must comply with current Slovak legislation. Anyone found to be disregarding this request will not be re-invited to attend. Please ensure that you follow this request to assist in keeping the reputation of the show Slovenské piestky (Slovak Sands) as being a "Safe Show".

### **Uniforms and Displays**

Wearing uniforms is possible and wantable. Uniforms of Axle countries may be used as a part of a static display or an arena event but they cannot be worn if any inconvenient decorations promoting nazism such as swastika are on them. Wearing present uniforms and ranking is governed by statutory regulations.

This is a great opportunity to display vehicles in the action in front of vast admiring audience as well as an opportunity to prove capabilities of both drivers and technicians in barriers overcoming. Arena events within the show are fun and designed to involve all types of vehicles. There will be a few surprises... Full details will be in the show programme which can be bought on arrival.

### **Car Parking**

There is a large parking area on the site. Cars will be towed to the parking area if still on the display area after 9.30 am. The only exception will be disabled persons vehicles displaying a current sign. You are welcome to use your bicycles to move around the site if ridden with care. Children may not ride motorcycles or quads during the show hours.

### **Displaying Military Vehicles**

If you are displaying your vehicle while sleeping in a tent or caravan you should leave all your domestic appliances to the rear leaving your military vehicle clearly parked out in front this will only enhance the overall quality of our show.

### **Vehicle & Camping Security**

This show is open to the general public and they will therefore have access to your vehicle. The Organisers can accept no responsibility for loss of or damage to your vehicle or its contents. In these circumstances we strongly recommend that you avoid leaving your vehicle completely unattended during the show. Should you wish to do so, we suggest that at the very least you arrange for someone with an adjacent vehicle to watch yours and upon return check your vehicle not only for any loss or damage but also for any suspicious package that may have been placed in, on or near your vehicle.

### **Litter**

Záhorie area is a very pleasant and attractive site and we hope that you enjoy our show. So as to ensure that we are invited next year again, it would be appreciated if you would place your litter in the plastic bags which will be provided and upon you finally leaving the showground deposit it in the litter bins.

### **Barbecue**

As the Záhorie area is situated in countryside the area is assumed to be dry and flammable during the show days. Barbecue is allowed providing that a suitable working fire extinguisher is available and the fireplace is min. 5 m far from flammable things or bushes. The fireplace must be watched all the time.

### **Fire Extinguishers**

Due to the health and safety guidelines, we must insist that all vehicles have a suitable working fire extinguisher. This will be checked during the show.

### **Generators**

Must conform to the current health and safety regulations and the Electricity at Work Regulations. This includes ground spikes (earthing). Any cost incurred ensuring that your generator complies with current legislation will be at your own expense.

### **Catering, Buffets and Sanitary Facilities**

There will be several buffets offering foods and drinks on the site. However, if you prefer to make your meal yourself you just can do that. Drinking water will be provided as well as showers and lavatories.

### **Fire Protection and Medical Care**

On the site fire emergency service as well as 24-hours emergency rescue is provided.

To make the show as safe as possible, the team are happy to offer advise on any matter relating to fire prevention. If necessary, they can inspect your campsite to check that it is safe. Advice costs nothing so please come and see us if you have any doubts over safety.

Fire and rescue services will be located in the centre of the site alongside the road and will be clearly marked.
